Flint Hills Association Eight-County Jurisdiction Housing Report



Market Overview

FHAR Jurisdiction Home Sales Rose in December

Total home sales in the FHAR eight-county jurisdiction rose by 25.4% last month to 158 units, compared to 126 units in December 2024. Total sales volume was \$39.9 million, up 15.3% from a year earlier.

The median sale price in December was \$242,500, down from \$253,750 a year earlier. Homes that sold in December were typically on the market for 35 days and sold for 98.5% of their list prices.

FHAR Jurisdiction Active Listings Up at End of December

The total number of active listings in the FHAR eight-county jurisdiction at the end of December was 340 units, up from 259 at the same point in 2024. This represents a 2.1 months' supply of homes available for sale. The median list price of homes on the market at the end of December was \$249,000.

During December, a total of 127 contracts were written up from 107 in December 2024. At the end of the month, there were 172 contracts still pending.



The median sales price in December was \$242,500, down 4.4% compared to the prior year. Median days on market was 35 days, up from 25 days in November, and up from 19 in December 2024.
